### Project Description:

The applicant proposes adverse modification of 8.96 acres of suitable habitat; with a loss of 5.71 acres of suitable nesting habitat for the Blanding's turtle (Embdoidea blandingii), a NYS-listed threatened species, associated with a 12-lot subdivision on 61.9 acres of occupied Blanding's turtle habitat, located in the Town of Wappinger. Net Conservation Benefit will be achieved by 12 acres of nesting area enhancements, 12 acres set aside in the declaration of easement, deed restrictions, and NYSDEC access for future study. Additional avoidance, minimization, and mitigation measures include no impacts to the wetland or its associated adjacent area, implementation of a time of year restriction for some activities, clustering of houses near to existing roadway, use of stormwater features, development of an Education and Encounter Plan, installation of temporary barriers during construction, and the use of a DEC licensed monitor.

### Availability of Application Documents:

Filed application documents, and Department draft permits where applicable, are available for inspection during normal business hours at the address of the contact person. To ensure timely service at the time of inspection, it is recommended that an appointment be made with the contact person.
