AGRICULTURAL DATA STATEMENT

Town of Wappinger

In accordance with Article 16 Section 283-a of the NYS Town Law (Chapter 62), an Agricultural Data Statement is required for any application for Special Use Permit, Site Plan Approval, Use Variance, or Subdivision Approval requiring municipal review by the Town Board, Planning Board or Zoning Board of Appeals, pursuant to Article 16, that would occur on property within an agricultural district containing a farm operation or on property with boundaries within 500 feet of a farm operation located in an agricultural district. The data contained within this statement will be used to evaluate the impacts of the proposed project on farm operations in or near Agricultural Use Districts. Note: Any property listed in the Agricultural Data Statement must receive notice of the application, which notice may be sent in conjunction with any other notice required by law.¹

2. Project Description:

Central Hudson Gas and Electric Corporation (Central Hudson) is proposing to reconstruct an existing 69 kilovolt (kV) electrical transmission line, known as the "KM Line" within an existing, cleared public utility right-of-way (ROW or Project Site). Total acreage of the subject ROW or Project Site is 37.5 acres.

The KM Line is owned and operated by Central Hudson. The existing voltage rating of 69 kV will be maintained with the reconstructed Line. The replacement project will take place within the existing ROW width. The entire ROW is appropriated to public utility use. The KM Line has existed in the ROW for nearly one-hundred years. Existing line conductors and poles have reached the end of their useful life. All existing poles on the KM Line will be removed and replaced nearly one-for-one in the same general location. within this existing, cleared and developed utility corridor.

The KM Line ROW traverses in a northwest direction from the border of the Myers Corners Substation on Myers Corners Road (Town of Wappinger), to an area just west of Victor Lane (Town of Poughkeepsie). *See* Location Map, Attachment A. The total length of the proposed replacement project is approximately 2.8 miles, with nearly 1.7 miles within the Town of Wappinger and nearly 1.1 miles within the Town of Poughkeepsie.

Approximately 9.66 acres of Agricultural District 22 lie within the KM Line ROW (all within the Town of Wappinger), of which approximately 2.8 acres will experience temporary disturbance to accommodate construction access, pole replacement, and wire pulling. However, no farming operations are readily apparent.

A total of nine poles will be replaced on land located within Agricultural District 22 for the KM line. Please note, the land within this location is mostly surrounded by forests and, as determined from site visits and aerial review, does not appear to be easily farmed without significant tree clearing. Considering these factors, the information provided in the Agricultural Data Statement, and Central Hudson's conservative approach, the KM Line Replacement Project will not result in adverse impacts to agricultural resources.


3. <u>Project Location</u>:
