Based on our review, we offer the following engineering related comments:

- 1. Provide elevations in the area of Detail #1 on Sheet CD.1.
- 2. The retaining wall detail on page CD.1 proposes an approximate 4-foot change in elevation, please show final grades at each retaining wall location to include bottom and top of wall elevations.
- 3. Provide a note within the Partial Site Plan (Detail #1 on Sheet CD.2) stating that final grading at entrance to loading dock access drive shall allow for drainage to be directed toward the existing storm sewer inlet.
- 4. Please include a construction detail for the proposed refuse enclosures for review.

5. Provide appropriate details and notation to repair and/or replace the rear (or western-most) portion of the ring road.
