Dear Chairman Flower and Members of the Planning Board:

On behalf of CarMax Auto Superstores, Inc, we are pleased to submit additional and revised information to the Town of Wappinger for review of the proposed CarMax Facility located at 1105-1115 Route 9 in the (HB) Highway Business Zoning District.

We have assembled this additional information following the comments heard at the May 1, 2023 Planning Board Public Hearing. The topic of pedestrian traffic and vehicle stacking on Smithtown Road was brought up by the comments heard at the meeting. As requested, we engaged a traffic engineer to study the pedestrian volumes along Smithtown Road and the stacking volumes on the western side of the Smithtown Road/US Route 9 intersection. The data obtained during peak hours for a Thursday, Friday, and Saturday is contained within the report. We also surveyed the entire width of the right-of-way of Smithtown Road for reference should sidewalks be built on either side of Smithtown Road. Lastly, we assembled sketches of sidewalk options for either side of Smithtown Road and those are included within this submission.
