WITNESSETH, that the party of the first part, in consideration of One Hundred Twenty-Five Thousand (\$125,000.00) Dollars paid by the party of the second part, does hereby grant and release unto the party of the second part, the heirs or successors and assigns of the party of the second part forever,

ALL that certain plot, piece or parcel of land, with the buildings and improvements thereon erected, situate, lying and being in the Town of Wappinger, County of Dutchess, most described as <u>Schedule A</u> attached hereto.

BEING AND INTENDED TO BE the same premises conveyed to Grantor by Deed dated June 2, 2014, and recorded June 26, 2014, in the Dutchess County Clerk's Office, as Document No. 02-2014-3768

TOGETHER with all right, title and interest, if any, of the party of the first part in and to any streets and roads abutting the above described premises to the center lines thereof; **TOGETHER** with the appurtenances and all the estate and rights of the party of the first part in and to said premises; **TO HAVE AND TO HOLD** the premises herein granted unto the party of the second part, the heirs or successors and assigns of the party of the second part forever.
